1. The **Belaka Municipality** invites *electronic* bids from eligible bidders for the procurement of **Procurement & Supply of Heavy Zinc Coated Gabion Boxes and NP3 Humepipe** under National competitive bidding – Single Stage Single Envelope procedures **for the third time**.

3. 5. Pre-bid meeting **shall not** be held.
6. Electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hours on 18-06-2026**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on 18-06-2026** at the **Municipality Office**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **75000.00**, which shall be valid for **30 days beyond the validity period of the bid**. (*i.e. 120 days from the deadline of bid submission*)
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
